About us

The Belarus-EU Business Council is an independent CEO-level forum for European and Belarusian leaders that is being set up as a non-profit organization in order to promote trade and investment between the EU and Belarus, to assist companies to develop business opportunities, to promote dialogue between governments and companies to help solve market access difficulties and overcome regulatory obstacles both for Belarusian businesses in the EU and EU businesses in Belarus.

Organisation of the Council

The Council has a full time Secretariat that works closely with our core sponsors ensure that the forward programme matches their strategic interests. The Secretariat is based in Brussels with representation in London. It provides a central policy, communications and resource function, and is responsible for planning and implementing the activities of the Council. The Secretariat is advised by a Council Advisory Group which is made up of academics, analysts, officials and advisers who help to provide expertise and develop policy. Since its establishment at the beginning of 2007, the BEUBC has been working to raise the profile of Belarus's businesses in the EU and to support discussions on Belarus-related issues in the EU, to study and analyze market access, regulatory obstacles, to develop targeted solutions for EU and Belarusian businesses, to help EU and Belarus businesses to represent business views and ideas to the European Parliament.

The BEUBC offers two different membership categories:

- Bronze, open to medium-sized companies, educational institutions, non-commercial organizations at subscription fee of 2000 EUR
- Gold, open to large and multinational companies at subscription fee of 10 000EUR
